Administrative Officer - 1 No. (UR) (Group-A, Level -10, 7CPC)

Essential Qualification: A Degree or its equivalent from a recognised University with 12 years of experience of work related to establishment and Administration Government Department or Organisation of repute in a supervisory capacity.

MBA/ LLB (or) Diploma Personnel in Desirable: Management and should be fully conversant with the Govt. of India Rules and Regulations.

<u>Upper Age Limit:</u> 45 years. Relaxation of 5 years for Department Candidates and usual relaxation for SC/ST/OBC candidates. (Age will be reckoned as on the closing date for submission of applications).

Essential Qualification: 1st Class BE in Mining/Civil/Geotechnical/ Electronics or equivalent (or) 1st Class M.Sc., in Geophysics/Geology/Applied Geology.

**Upper Age Limit:** 30 years. Relaxation of 5 years for Department Candidates and usual relaxation for SC/ST/OBC candidates. (Age will be reckoned as on the closing date for submission of applications).

**Desirable:** 1st Class M.Tech/ ME in the above disciplines or two years experience in research/ teaching/ industry in rock mechanics or related field.

- The candidate must be a citizen of India. 2.
- 3. The appointment will be on regular basis with a probation period of 2 years.
- 4. Crucial date for claim of SC/ST/OBC status or any other benefit viz. reservation, age-relaxation, etc., where not specified otherwise, will be the closing date for submission of applications.
- A person seeking appointment on the basis of reservation to OBC /SC / ST must ensure that he possesses the 5. relevant certificate on the crucial date. Candidates may also note that in respect of the above, their candidature will remain provisional till the veracity of the concerned document is verified by the Institute. The candidates claim document is verified by the Institute. benefit of reservation under EWS are required to submit the Income and Asset Certificate (I & AC) in the prescribed format issued by a Competent Authority.

- 7. The prescribed qualifications are the minimum required and the mere fact that a candidate possesses the same will not entitle for shortlisting of their candidature.

- 10. Selection of candidate will be made based on personal interview of the sort-listed candidates by a designated selection committee at the Institute. Mere fulfilling the minimum qualifications and experience will not vest any  $right on \, a \, candidate \, for \, being \, called \, for \, interview.$
